3 bids were received. The Dodge Ram seemed to be the most practical. The cost, outfitted, would be around \$40,841.00.

The Mayor felt that some other city vehicles were becoming vulnerable as well. The city could get a 2018 faster and a 2019 would take longer at nearly the same price.

Chief Eimer felt that a 4-wheel drive was needed for this area.

The City's reserve fund could be used again for the purchase, so no money would be spent for interest.
