Also some leaks had shown up in the roof over the Rescue Squad room. First responder training was continuing. Seven people were in training.

Randy Brooks gave a short report on the Golf Course. There had been a senior outing with about 17 people attending.

Mike Harrison told the Council that Second St. was seeded. The work started at Buena Vista and Josephine St. Approximately a block of tile needed to be replaced. Mike reported that the filter media needed to be changed. Prices will be secured before purchases are made. Mosquito spraying was continuing. Drainage was discussed and certain areas were outlined that needed attention. Repairs will proceed as funds are available.

The Mayor reported that communications were on going between the Engineer and the Brandts. Some progress has been made.

The Council took up the Tele-Pharmacy project. TIF figures were given to the Council for review. The Ordinance and Redevelopment agreement attached.
